IN CONSIDERATION of being able to participate in scuba diving activities conducted by Downey Diving Services of 213 Summerfield Drive, Baden Pennsylvania 15005, Releasor, for him/herself and his/her legal representatives, heirs, beneficiaries and assigns, hereby releases, waives and discharges, AMBROSIA COAL & CONSTRUCTION COMPANY, its entities, officers, directors, shareholders, insurers, agents, servants and employees, and ROSE AMBROSIA, her legal representatives, heirs, beneficiaries and assigns, hereafter referred to as "Releasees" from all liability to the Releasor and his or her legal representatives, heirs, beneficiaries and assigns, for any and all loss or damage, and any claim or damages resulting therefrom, on account of injury to Releasor's personal property, even injury resulting in death of the Releasor, whether caused by the negligence of Releasees or otherwise while the Releasor is participating in scuba diving at the Strawberry Fields Quarry in Washington Township, Lawrence County, Pennsylvania.

Releasor agrees to indemnify the Releasees and each of them from any loss, liability, damage or costs they may incur due to the presence of Releasor in or upon the Strawberry Fields Quarry, whether caused by the negligence of the Releasees or otherwise.

Releasor hereby acknowledges that he/she is aware of the inherent hazards of snorkeling, skin diving, and scuba diving. Releasor understands that diving with compressed air involves certain inherent risks including, but not limited to, decompression sickness, embolism and other hyperbaric injuries, which injuries require treatment in a recompression chamber. Releasor hereby acknowledges that he/she is adequately and properly trained and certified for this activity. Releasor understands that diving is a physically strenuous activity and could involve the risk of heart attack, panic, hyperventilation and like injuries.

Releasor hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of Releasees or otherwise while in or upon the Strawberry Fields Quarry for the purposes of scuba diving.

Releasor expressly agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the Commonwealth of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

This release contains the entire agreement between the Releasor and Releasees and the terms of this release are contractual and not a mere recital. Releasor further states that he/she has carefully read the forgoing release and knows the contents thereof and signs this release voluntarily.

Releasor hereby states that he/she is of lawful age and legally competent to sign this release or that the written consent of Releasor's legal guardian has been obtained.
